Dislocated Worker JD-NEG Grant

61 dislocated workers enrolled since beginning of grant

38 enrolled in short-term institutional training in high demand industry

47 have received some type of additional supportive services

7 clients have been placed in OJTs (we are leading the State in OJTs)

4 have been placed in registered apprenticeships.

Success Story- TJ is a disabled Vet from Waverly who worked at GMT Corporation. GMT was a direct supplier to TEREX Corporation who closed their doors and TJ found himself laid off with no clear recall date. After coming to our Center, TJ was co-enrolled in all the programs in which he was qualified. He has been placed in an apprenticeship program with Jim Hundley HVAC and plumbing, and will do an OJT with Hundley while also taking institutional training through Hawkeye Community College's HVAC Apprenticeship program for two years. Hundley HVAC and Plumbing is a registered apprenticeship employer and have been very active in hiring veterans. TJ is receiving other supportive services including mileage reimbursement and tools for his trade.

WIOA Youth/Young Adult Program

18 paid work experiences started since July, 2016 Completed 12 paid work experiences in the Mayor's Summer Youth Program

With WIOA's focus on out-of-school youth, outreach is occurring with the ELL classes at the HCC Metro Center. We continue to recruit from the High School Completion Program at Metro.

Joint Professional Development Day – October 10, 2016

WIOA Core Partner staff — Voc Rehab, Adult Education & Literacy, Iowa Department for the Blind, and IowaWORKS — met for an all-day training at HCC Tama Hall. Some of the trainings included cultural sensitivity, accommodations in the workplace, and apprenticeships. Shared success stories were presented and staff broke into smaller groups to discuss next steps for collaboration. Committees were established to begin implementation of brainstormed ideas.
