Ocwen notified us that they will be laying off another 288 employees who fall under the existing Trade petition. The layoffs will occur as follows:

# **Dislocated Workers**

Ocwen - Six Worker Information meetings, including Trade Act Assistance state staff, have been held. Two each in October, December and January and all affected employees were invited. IowaWORKS staff is working with approximately 130 dislocated workers from Ocwen. WIOA Dislocated Worker Program – Five dislocated workers have been co-enrolled in training utilizing DW-program dollars along with GAP assistance. Three are in CDL training and two are in CNC machining.

# WIOA Young Adult Program

- Currently we have 5 paid work experiences in progress; we are in the process of arranging 8 more paid WEP's
- There are 9 out of school youth that we have enrolled from our efforts in recruiting students in HCC's High School Completion Program; 2 have recently finished!

- We continue to offer Leadership workshops twice a month on Wednesdays from 3-5pm; our attendance averages about 8 students per session.
- There are 5 students that are enrolled in post-secondary education, 2 of whom are in short term training programs, where we are assisting with tuition, transportation, childcare, or miscellaneous expenses.
- We have 12 students enrolled in secondary education (high school). We are addressing which of these students might benefit from a paid work experience also.

### Wal-Mart Grant

Iowa Workforce Development, Cedar Valley IowaWORKS and Hawkeye Community College was awarded a Walmart Foundation Grant in the amount of \$75,000.00 to introduce low-income Iowa women and minorities to construction jobs. According to the latest "Promise JOBS Employment and Wage Report", construction is the second highest paying industry for men enrolled in the PROMISE JOBS program. A demographic breakdown of individuals working in this occupation indicates females represent only 2.3 % of the workforce.

The grant funds are being used to bring a specialized Hawkeye Community College construction equipment simulator along with a general instructor and assistant to each of Iowa's 15 IowaWORKS offices in 2016. The simulator is part of the "six steps workshop", which allows women in the Promise Jobs program the opportunity to learn about non-traditional construction jobs and experience hands on simulator to operate equipment.

This program will run from January-June 2016 in the IowaWorks locations across the state. The event was well publicized by State and Local press. Region 7 Cedar Valley IowaWORKS had a total of 53 customers and staff visits the Construction trade trailer during the week of Jan 10, 2016 to Jan 15, 2016.
