

Adult Education Report—June 2016

Enrollment Update

As of June 20th, we have met of our FY16 enrollment goal. This year's goal was 1050 students and we are at 1105, which is 105% of the goal. Have also met our 60% post-test goal. Our post-test percentage and overall level completions are ahead of our FY15 performance. (See attached chart.)

Commencement Ceremonies

We celebrated commencement exercises at the Anamosa State Penitentiary and the Iowa Medical and Classification Center the week of June 20th. Students earning a high school diploma or its equivalent, as well as those who completed an apprenticeship program or non-credit certificate program were recognized. Kim Becicka provided the remarks at the ASP ceremony, while Lois Barteleme, Kirkwood Board of Trustees President, was the guest speaker at IMCC.

CEA Accreditation

Our prison education programs at IMCC and ASP are accredited through the Corrections Education Association, a national organization that works with correctional facilities across the United States. State facilities in Iowa have been working with CEA on accreditation for a number of years. This year, IMCC was due for its 3 year review and visit. A CEA auditor visited the facility on June 15th and has recommended reaccreditation for our programs.

WIOA One Door Many Paths Conference

Kirkwood adult education staff attended and presented at the WIOA conference on June 27th and 28th. Marcel Kielkucki, Kelly Scanlon, and Marion Patterson presented on our Pathways to Success course being piloted on main campus. Cyd Hanson presented on the STAR reading program, and Robbin Rekemeyer presented on College and Career Readiness Standards. Ten members of the adult education team attended this year's event.
